

FEES: Tuition and materials fees are payable *in advance* by credit card via the school's website www.pdxmusicschool.com, or by check or credit card at the front desk. Please refer to the document *Portland Music School Fees*, on the website and included in your Student Packet for payment options and due dates.

MISSED LESSONS: Consistent class attendance is of the utmost importance in order to assure musical growth. For absences other than illness, advance notice is appreciated. *Portland Music School does not give refunds or tuition credit for missed lessons.*

VACATIONS: Your teacher will appreciate advance notice of absences due to family vacations. The student may attend a group lesson as a make-up, if available. Please ask the front desk for make-up class offerings. *Portland Music School does not give refunds or tuition credit for vacations.*

MAKE-UP LESSONS: A student may attend another group class as a make-up lesson for an absence, if available.

TEACHER ABSENCE, CLASS CANCELLED: Every reasonable effort will be made to arrange for a make-up lesson if a class is cancelled by a teacher. If a make-up lesson cannot be made up, the school will issue a credit.

WITHDRAWALS: Formal written notification of withdrawal must be given to the office. Materials fees are non-refundable. The customer agrees to provide Portland Music School with advance written notice of 30 days when withdrawing. No refund is issued for any remaining class sessions scheduled for the current month when a student withdraws during the month. If tuition payment has been made in advance for more than one month, refunds will be prorated at the **full** cost of tuition. No tuition discount will be allowed for early withdrawals.

INSUFFICIENT FUND CHECK: The customer agrees to pay a \$35.00 processing fee for returned insufficient fund checks.

CLASS CANCELLATION: Portland Music School reserves the right to cancel, reschedule, regroup, discontinue classes or reassign teachers as deemed necessary. Full refunds and registration fees are issued in the case of class cancellation due to insufficient enrollment or schedule change prior to first day of class.

WEATHER-RELATED OR OTHER SCHOOL CLOSURE: You will be contacted in the event of inclement weather or other emergencies. Please note that Portland Music School does not necessarily follow the weather cancellation decisions of the local public schools. Portland Music School does not issue refunds for weather-related cancellations or cancellations due to circumstances beyond the school's control. Two weeks weather-related makeup classes are tacked onto the June schedule.

Please be aware that these photos are for promotional purposes and may be used in future publications and media communications. PARENT/GUARDIAN ATTENDANCE: Parents, guardians, grandparents, friends and siblings are not allowed to attend the group classes except for in-class performances. One or two parents or guardians may attend Preview Lessons.

SOME ADVICE ON STUDYING MUSIC: You or your child's interest in music lessons may ebb and flow like all activities in life and may not always maintain a steady level. Some weeks the practice time will be easily managed and every day; other weeks it may be infrequent. Consistent attendance will aid in musical success whether or not the practice was steady, so do not skip class just because there hasn't been enough practice or because the student says he or she doesn't want to go to class. These fluctuations of interest are PERFECTLY NORMAL and should not signal an end to the musical training. If you are uncomfortable with any aspect of the lesson, please discuss it with your teacher before you make a decision to stop valuable musical training. If it becomes absolutely necessary for the student to terminate lessons, 30 days written notice is required.
